
## Right Sofa

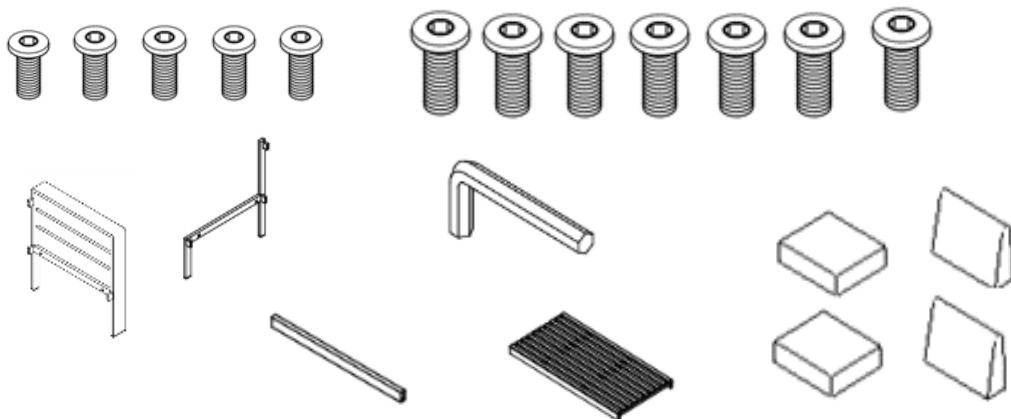

- Do not assemble on flooring or carpet-



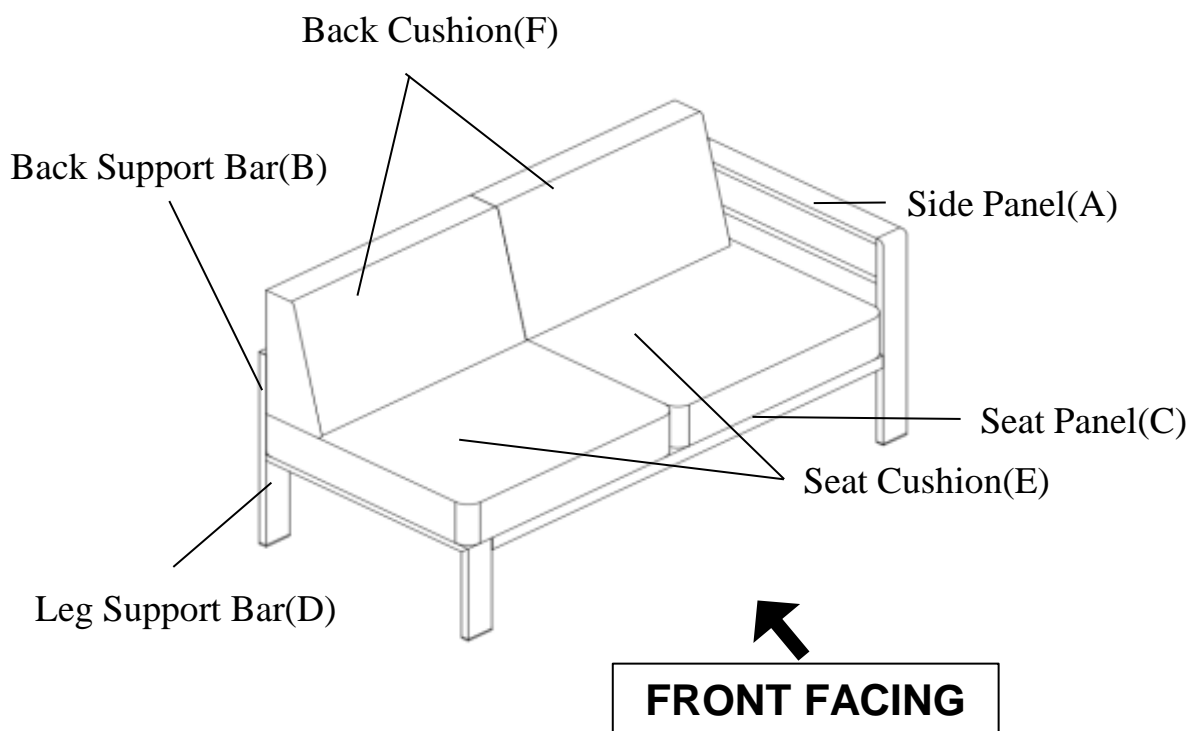
- Assemble on a clean non-marring surface (packing foam)-



- Save all packaging until finished-

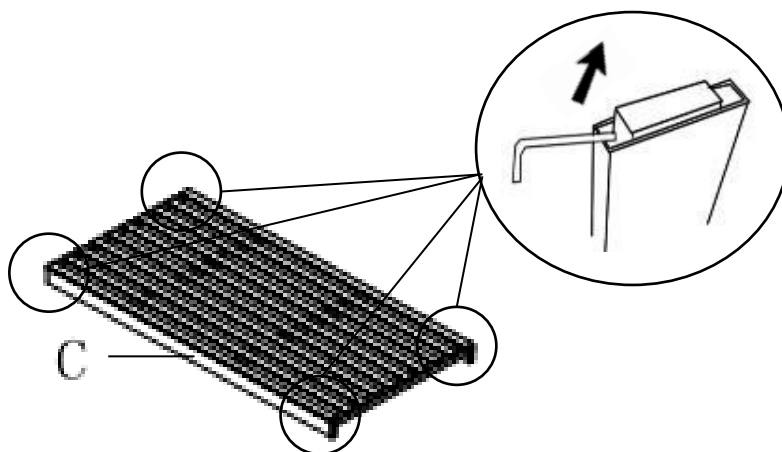
## Assembly Steps

### Overview



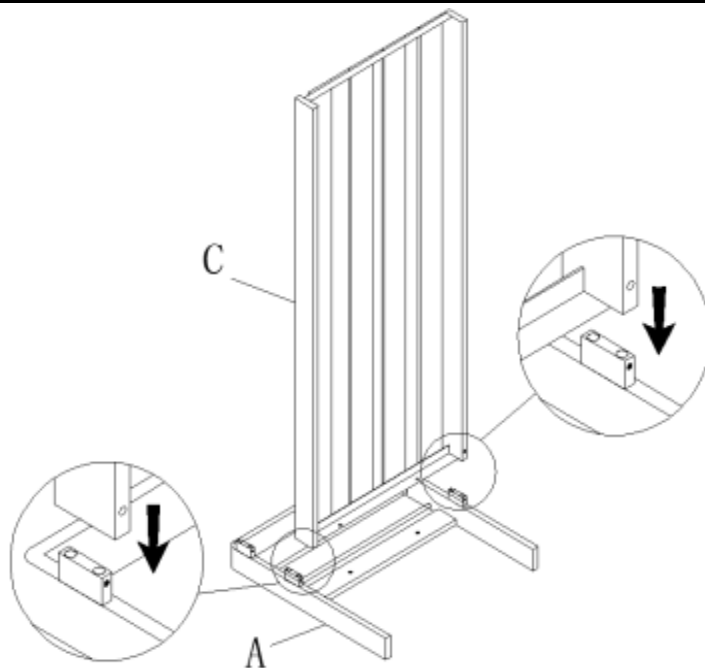
This Sofa has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Sofa parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.

### Step 1



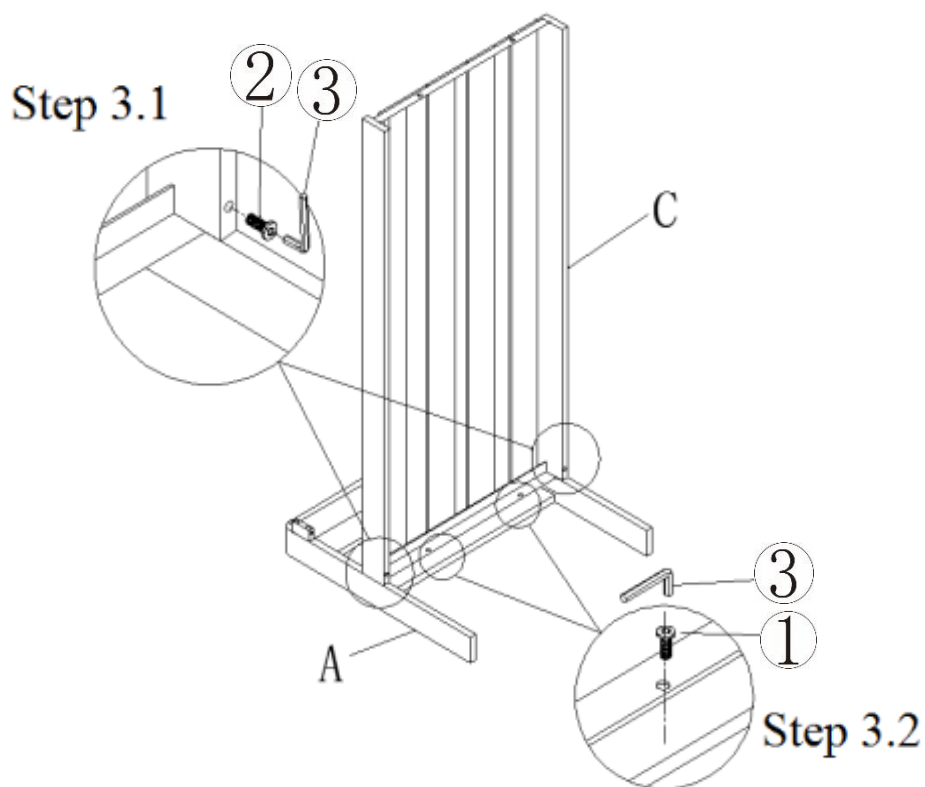
Open the carton and place all the parts onto a clean, non-marring surface.  
Take out the plastic plug ( prevent the alum tube was scratched) in the four ends of the Seat Board(C) using Allen key (③) as shown above.

## Step 2



Place the Side Panel(A) with its inside facing up.  
Insert Seat Panel(C) into the Side Panel(A).

## Step 3

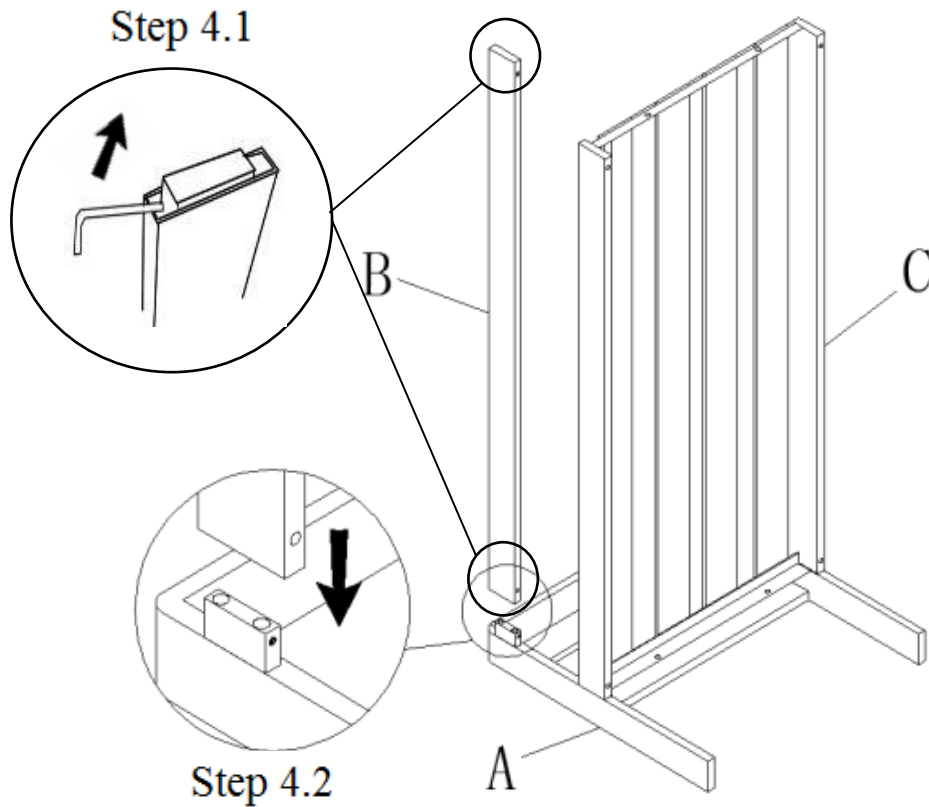


**3.1)** Attach the Seat Panel(C) to Side Panel(A) using Bolts(②) with Allen Key(③) as shown above.

**3.2)** Attach the Seat Panel(C) to Side Panel(A) using Bolts(①) with Allen Key(③) as shown above.

**Do not fully tighten Bolts.**

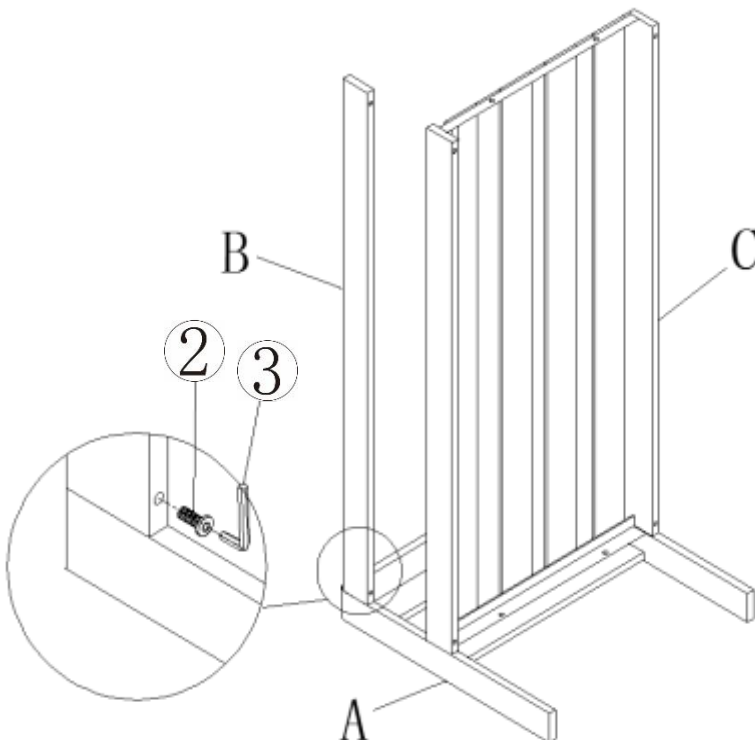
## Step 4



**4.1)** Remove the plastic plugs( prevent the alum tube was scratched) in the both ends of Back Support Bar (B) using Allen Key(③) as shown above.

**4.2)** Insert the Back Support Bar(B) into the Side Panel(A).

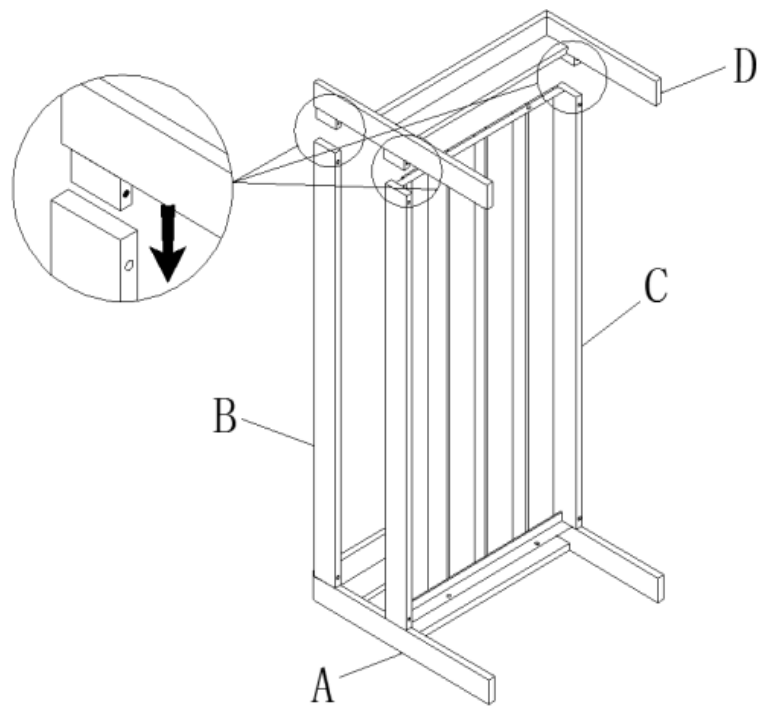
## Step 5



Attach the Back Support Bar(B) to the Side Panel(A) using Bolt(②) with Allen Key(③).

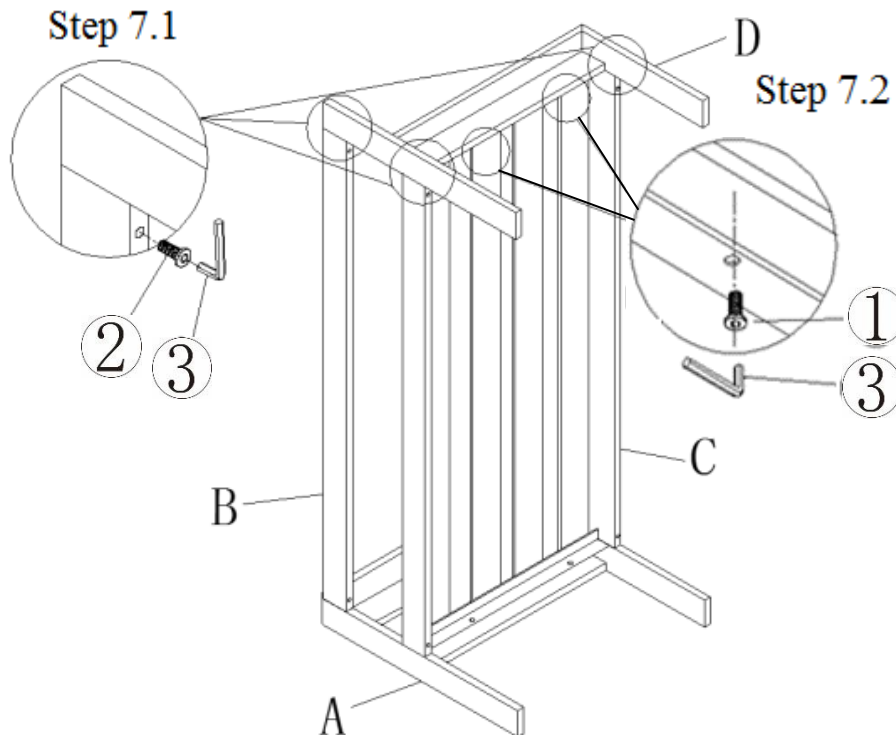
**Do not fully tighten Bolt.**

## Step 6



Insert the Leg Support Bar(D) into the Back Support Bar(B) and Seat Panel(C) as shown above.

## Step 7

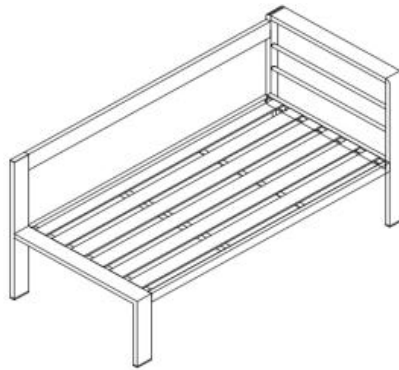


**7.1)** Attach the Leg Support Bar(D) to Back Support Bar(B) and Seat Panel(C) using Bolts(②) with Allen Key(③) as shown above.

**7.2)** Attach the Leg Support Bar(D) to Seat Panel(C) using Bolt(①) with Allen Key(③) as shown above.

**Do not fully tighten Bolts.**

## Step 8



Stand the Sofa up.

Place the Sofa on a **LEVEL SURFACE**.

Inspect it and make sure all parts are adequately connected.

Gently and carefully, sit onto the Sofa.

This will help to align all parts at all the joints.

Then get off the Sofa, and in a sequential manner, proceed to tighten all Bolts.

**When tightening the Bolts, tighten sequentially.**

**DO NOT tighten any Bolt fully and then move on to the next one.**

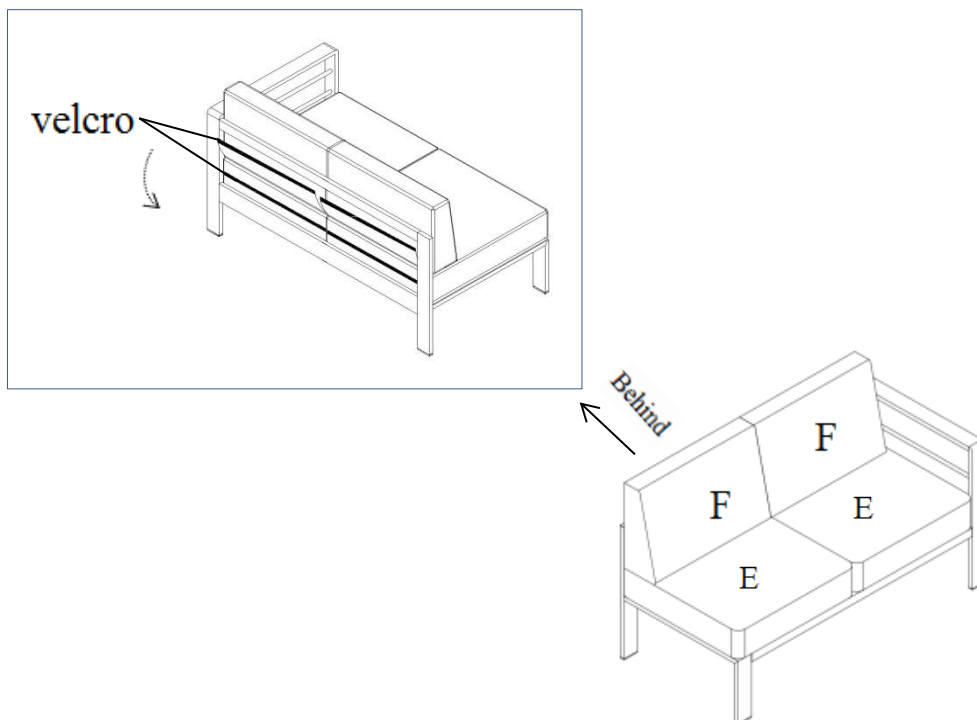
**This may cause the frame to warp.**

**If there are still wobbles, loosen the Bolts and execute the same process.**

**If the Sofa is not stable it could lead to damage to the product.**

**Note: This step is done best with the assistance of a second adult.**



















## Step 9



Put Seat Cushions(E) and Back Cushions(F) on the Sofa and stick the velcro from back cushion to seat cushion as shown above.

Your Right Sofa is ready for use.

## Care & Maintenance

-   Do not put hot items directly on furniture surface
  -   Do not clean furniture with harsh cleansers or polish.
  -   To obtain the longest lifespan of your outdoor products, minimizing exposure to direct sunlight is recommended.
  -   Children should not climb or jump on the furniture.
  -   Do not write on furniture without a padded barrier to protect the surface.
  -   To obtain the longest lifespan of your outdoor products, avoid extended and lengthy exposure to rain, snow, and direct sunshine. Whenever possible cover the product and /or place under patio or awnings.
  -   Not for commercial use. For residential use only .
  -   Stains may be removed with mild soap solution and damp cloth.

-   Dust and pick-up spills using a clean, non-colored, lint-free cloth .

## Questions & Answers about Proposition 65

### • What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

### • What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

### • What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
