
Front Legs with Washers (2)






Rear Legs with Washers (2)


Remove all parts from the carton and place them on a protected surface or carpet. Take out the wood legs (C & D) out of the box as shown.



**2.** Remove the plastic caps on the threaded bolts of each leg. Attach the wood legs (C, D) to the corners of the recliner as shown.





**3.** Attach the back cushion (B) to the seat cushion (A) by sliding the receivers into the mechanism posts located on the seat cushion (A). From the front of the recliner, press down on both sides of the back cushion (B) to firmly secure. The back cushion (B) and seat cushion (A) will automatically lock into place. Then pull the back flap down tightly and attach the back flap to the bottom of the seat cushion (A).




#### **Operating instructions**

While seated, push the back cushion to recline so it will move backwards and the footrest will raise at the same time. To return the footrest to the closed position, apply more weight onto the footrest.

### Limited Warranty
