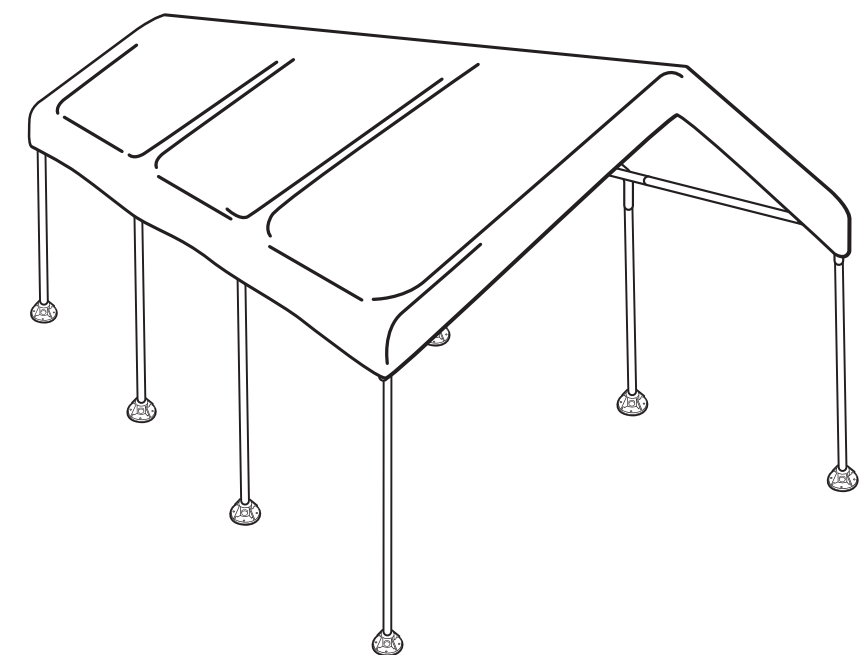
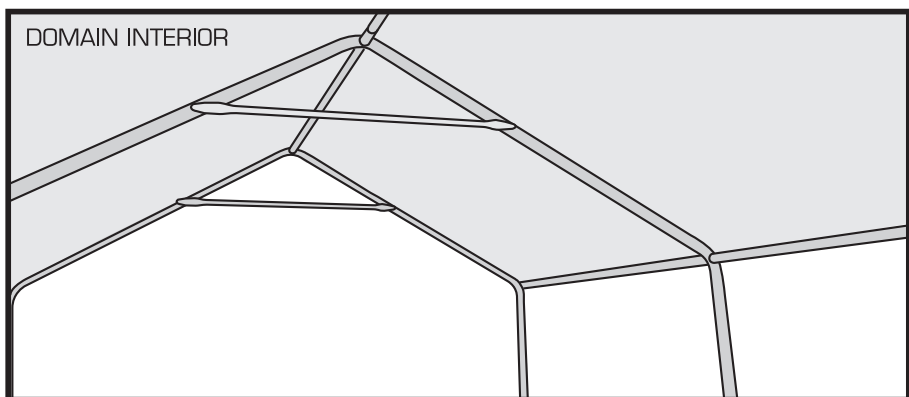
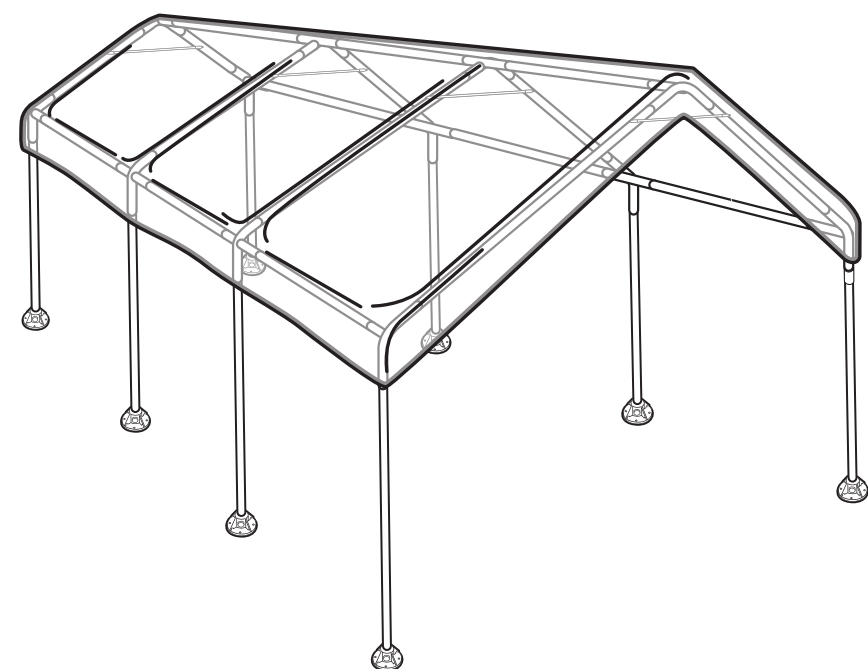


CARAVAN SET UP INSTRUCTIONS



WARNING

Use caution during installation. The user assumes all risk of injury during setup and use. Please follow the following safety precautions to avoid injury.

1. Do not use the canopy as a permanent shelter. It is designed for temporary use only!
2. Never set-up or continue to use the product in rainy, windy or stormy conditions, especially lightning storms. Please remove your canopy top before a storm.
3. Keep your canopy off of steep slopes and inclines
4. Have at least two adults helping during installation. Read all instructions carefully and follow accordingly. Failure to do so may result to injury or damage to the canopy.
5. Always inspect the canopy and each part before use. Make sure that everything is tightly secured. Replace any worn, defective or missing parts.
6. After installation, the canopy should be anchored to prevent damage and possible injury. It is the user's responsibility to properly anchor the product.
7. Do not set-up or use the product in close proximity to fire or any heat source. Do not use a barbecue grill under the canopy.
8. Do not bleach canopy cover, dry clean, wash in the washing machine, or dry in the dryer. Use only mild soap and water. Hang to dry.

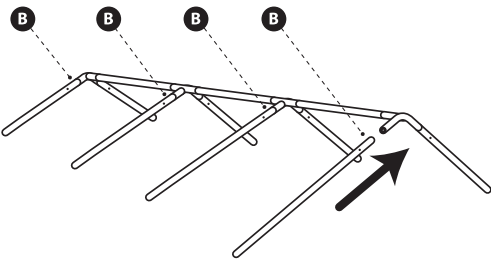
STEP 1 LAY OUT ALL PARTS BASED ON DIAGRAM BELOW



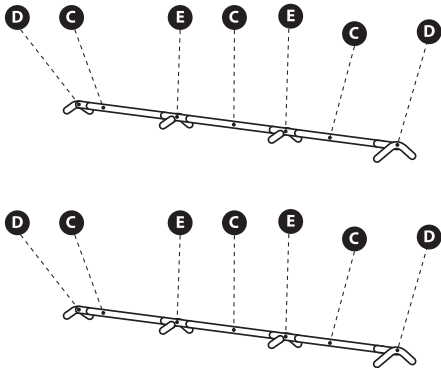
STEP 2 COMBINE THE CENTERPIECE



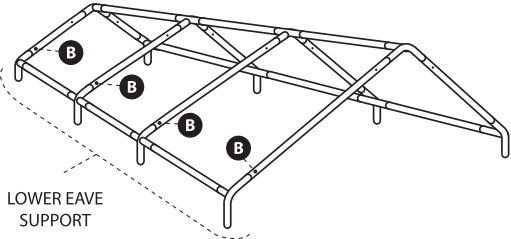
STEP 3 CONNECT B2 SIDES TO CENTERPIECE



STEP 4 ASSEMBLE BOTH LOWER EAVE SUPPORTS

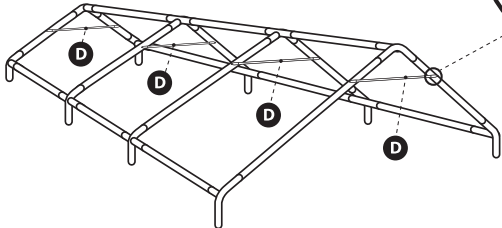


STEP 5 CONNECT B1 SIDES TO LOWER EAVE SUPPORTS



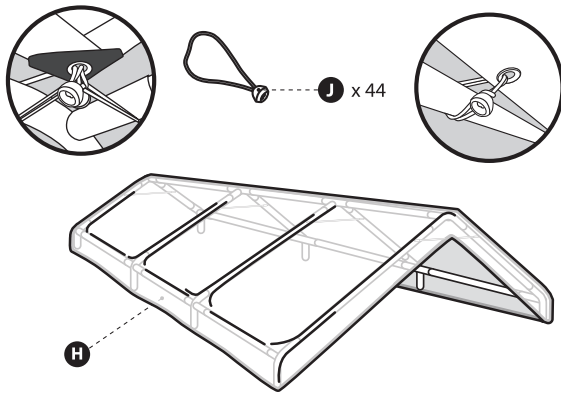
STEP 6 CONNECT SNOW LOAD BARS

Attach with snow load nut & bolt (K).



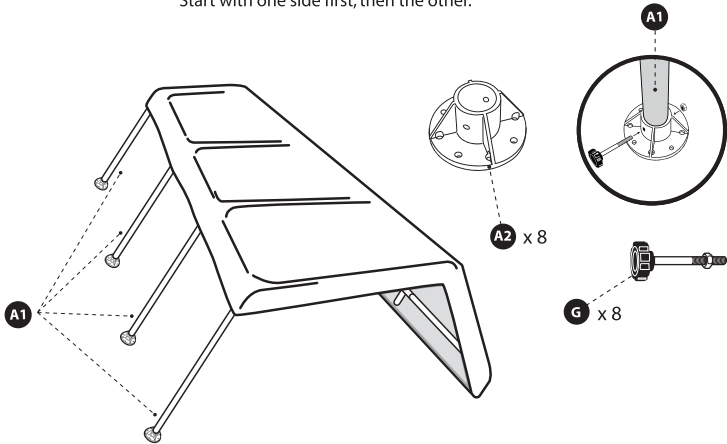
STEP 7 PLACE CANOPY TOP

Secure each corner with the elastic ball straps. Then secure all other grommet points with the remaining ball straps.



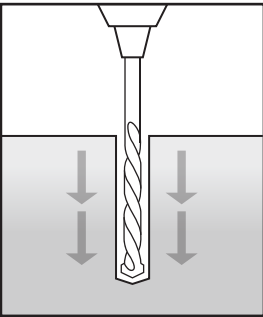
STEP 8 CONNECT LEGS & FEET

Secure canopy feet (A2) to canopy legs (A1) first. Then attach canopy legs. Start with one side first, then the other.

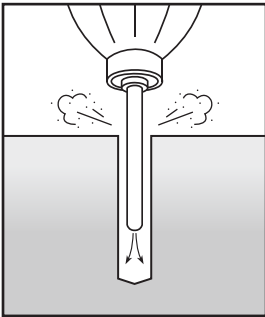


STEP 9 SECURE EXPANSION BOLTS TO CONCRETE

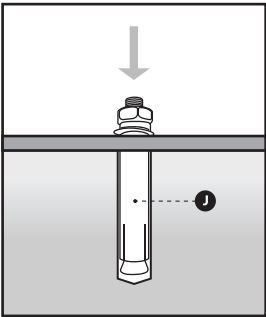
Drill hole in concrete to required depth.



Remove all debris from hole.



Insert expansion bolt through canopy foot into concrete.



Fasten nut with socket wrench to fully secure expansion bolt to concrete.
