3.3 FIX LEFT OUTSIDE LEG #01 TO PIECES #05, #08, #13, #14 AND #15, USING (06) SCREWS (G), A PHILLIPS HEAD SCREWDRIVER (NOT PROVIDED), THE WOODEN DOWELS ALREADY INSERTED AND THE PRE-DRILLED HOLES AS GUIDE, AS PER DRAWING BELOW.

3.4 TURN THE PIECE IN THE UPRIGHT POSITION AND FIX THE BACK AND FRONT RAILS #14 AND #15 TO THE LEFT OUTSIDE LEG #01, USING (04) SCREWS (G), A PHILLIPS HEAD SCREWDRIVER (NOT PROVIDED) AND THE PRE-DRILLED HOLES AS GUIDE, AS PER DRAWING BELOW.

To increase the resistance of the piece, you can use glue on the tenons when assembling the rails to the leg.



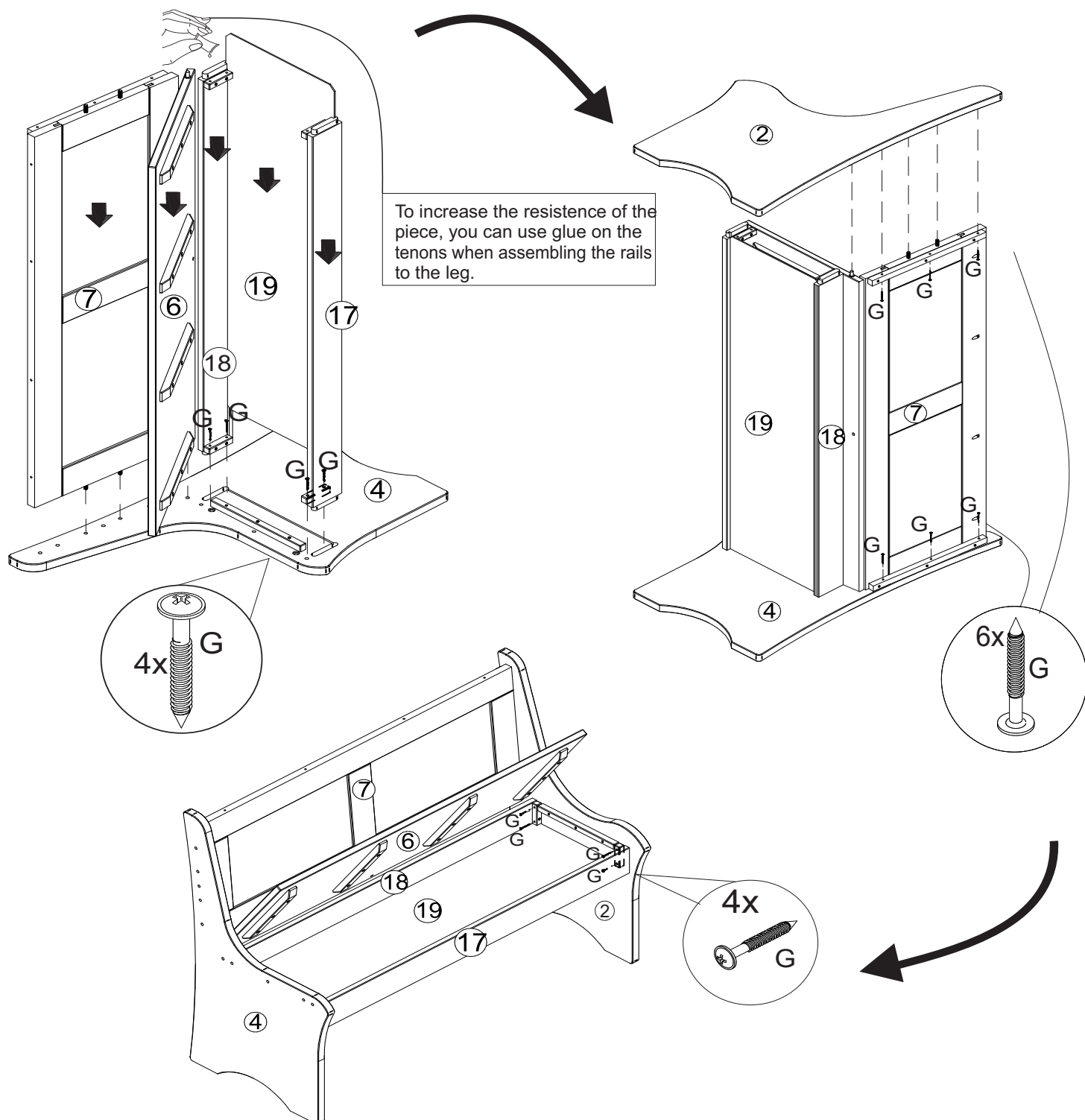

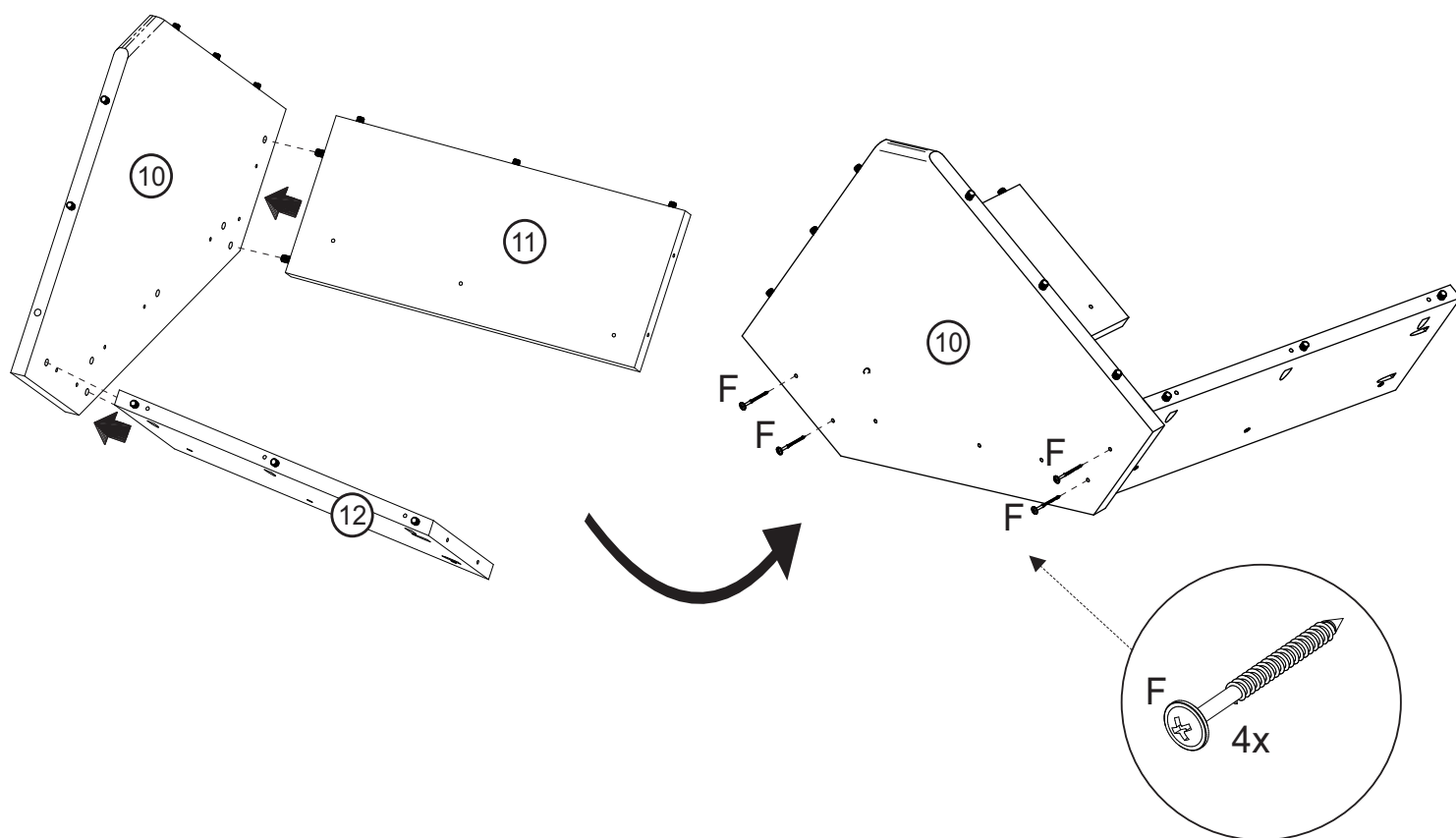

3.4 TURN THE PIECE IN THE UPRIGHT POSITION AND FIX THE BACK AND FRONT RAILS # 17 AND #18 TO THE RIGHT OUTSIDE LEG #02, USING (04) SCREWS (G), A PHILLIPS HEAD SCREWDRIVER (NOT PROVIDED) AND THE PRE-DRILLED HOLES AS GUIDE, AS PER DRAWING BELOW.
