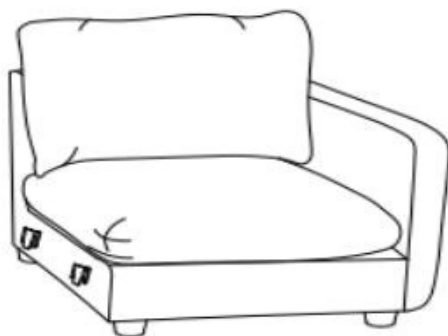

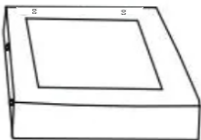

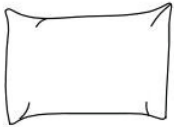

Right Armchair

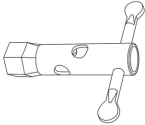

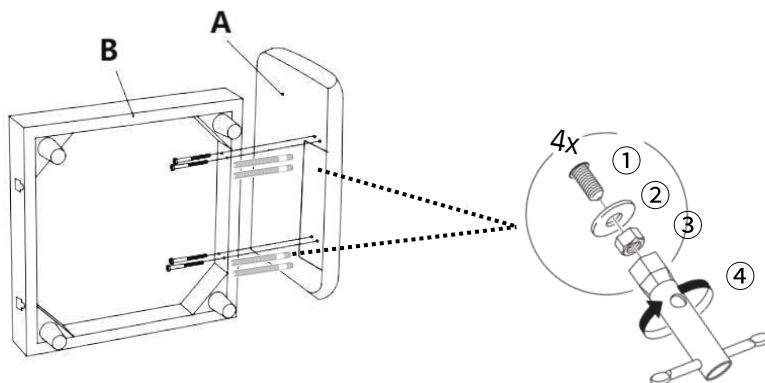
This right armchair has multiple parts and may require up to some 15 minutes to assemble. To give you an overview of the parts, the above picture is to help you put the various parts into perspective. Please read through the instructions carefully before assembly.

Step 1



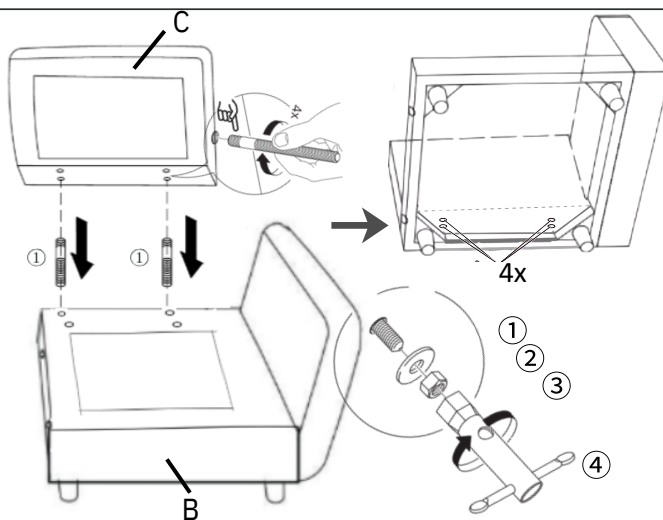
Assemble leg (D) and plastic gasket ((5)) with seat base B, then rotate clockwise.

Step 2



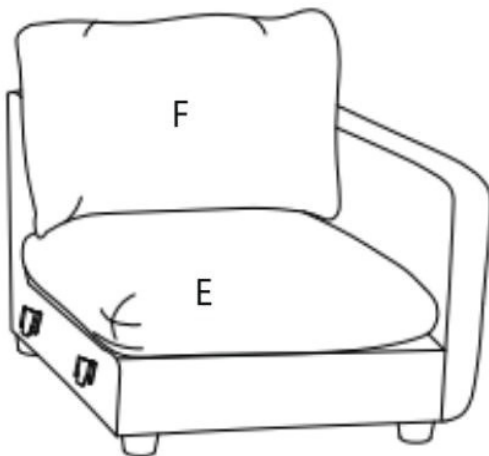
Place the seat base (B) and the right armrest (A) on the side, and then fix them together with screws (①), washers (②), nuts (③). Finally, use the key hollow (④) to tighten the screws (①), washers (②), and nuts (③).

Step 3



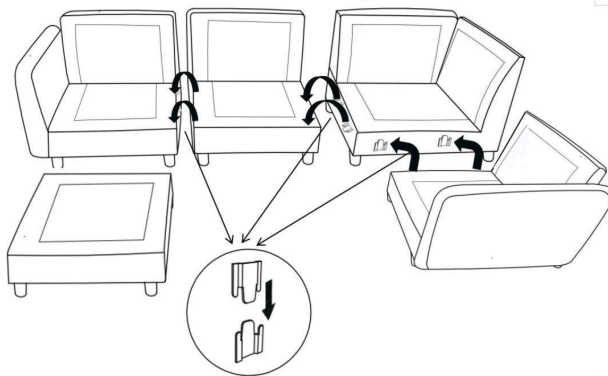
First, install screws (①) on the backrest (C). Then, from the back side of the seat base (B), install washers (②) and nuts (③). Finally, use the hollow key (④) to tighten the screws (①), washers (②), and nuts (③).

Step 4



Unpack the back cushion (F) and seat cushion (E) (restore to their original state in 3 minutes), and arrange as shown above.

Step 5



With the assistance of your adult partner, place the Chairs facedown and connect the chair using the installed mountain shaped insert.

Note: This is an optional step in case you want to connect all the Chairs in the set together and should be performed before affixing the cushions.

- What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.

Left Armchair

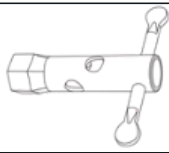

Step 1



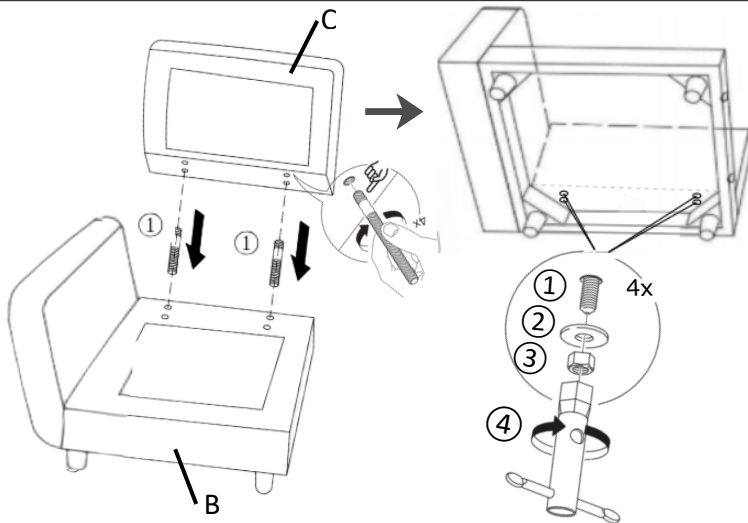
Assemble leg (D) and plastic gasket (5) with seat base (B) and rotate clockwise

Step 2



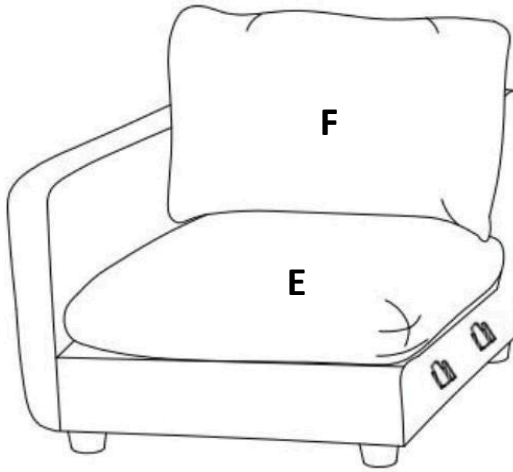
Place the seat base (B) and the left armrest (A) on the side, and then fix them together with screws (1), washers (2), nuts (3). Finally, use the key hollow (4) to tighten the screws (1), washers (2), and nuts (3).

Step 3



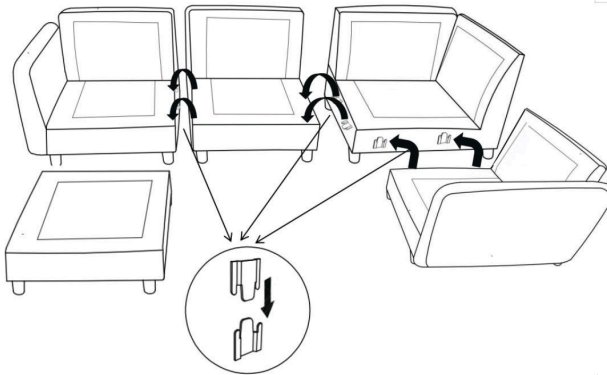
First, install screws (1) on the backrest (C). Then, from the back side of the seat base (B), install washers (2) and nuts (3). Finally, use the hollow key (4) to tighten the screws (1), washers (2), and nuts (3).

Step 4



Unpack the back cushion (F) and seat cushion (E) (restore to their original state in 3 minutes), and arrange as shown above.

Step 5



With the assistance of your adult partner, place the Chairs facedown and connect the chair using the installed mountain shaped insert.

Note: This is an optional step in case you want to connect all the Chairs in the set together and should be performed before affixing the cushions.

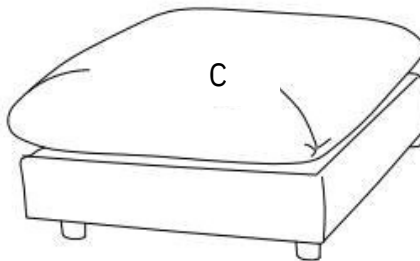
