- When originally purchased directly or from an authorized IRON WOODS® distributor, dealer or contractor.
- When used in normal residential or commercial applications and service conditions,
- When installed in accordance with Iron Woods "Best Practices",

Will not suffer structural damage from insect infestation or fungal decay for a period of 10 years from the date of the original purchase from an authorized IRON WOODS distributor or dealer. Coastal Forest Products reserves the right to have a representative inspect the material. Purchaser's sole remedy for any claim whatsoever, whether in contract, warranty, tort, or strict liability, arising from the use, storage or possession of IRON WOODS Deck Tiles including without limitation any claim that IRON WOODS Deck Tiles failed to perform as warranted above, shall only be the replacement of the specific IRON WOODS Deck Tiles that were affected.

This warranty does not cover and Coastal Forest Products shall not be liable for the following...

Damage caused by natural change in physical properties of Iron Woods Deck Tiles beyond control of the product.

Damage to iron Woods Deck Tiles resulting from an unstable substructure, improper design and/or improper installation by any third party.

Any and all costs associated with delivery, installation, removal, or disposal of Iron Woods Deck Tiles.

Any and all in, ground contact or submerged applications of Iron Woods Deck Tiles.

Warrantor does not warrant that, and Purchaser is solely responsible for, determining whether IRON WOODS Deck Tiles meet the requirements of any applicable safety code or similar regulation. Warrantor shall not be liable for installation, removal or reinstallation costs or for any indirect, punitive, exemplary or consequential damages of any kind whatsoever.

No person or entity is authorized by Warrantor to make, and Warrantor shall not be bound by, any statement of representation as to the quality or performance of IRON WOODS Deck Tiles other than contained in this warranty.

THE FOREGOING WARRANTY IS EXCLUSIVE AND IN LIEU OF ANY AND ALL OTHER WARRANTIES WITH RESPECT TO IRON WOODS IPE DECKING, AND THERE ARE NO OTHER WARRANTIES WHETHER EXPRESSED OR IMPLIED, INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

To initiate the claim process, the owner must send this warranty certificate, along with the original purchase invoice indicating the date, and description of Deck Tiles purchased from an authorized IRON WOODS wholesaler, dealer or professional contractor directly to Coastal Forest Products Claims Department.

There are no oral promises or representations collateral to or affecting this warranty and it may not be altered except in a written instrument signed by both Warrantor and buyer. Some states do not allow limitation on how long any implied warranty lasts and/or the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you. This warranty is only valid in the contiguous 48 states. This warranty gives you specific legal rights and you may also have other rights which vary from state to state.
