# ORGANIZER DESK LAMP

## **IMPORTANT SAFETY INSTRUCTIONS:**

This portable lamp has a polarized plug (one blade is wider than the other). As a safety feature to reduce the risk of electrical shock and fire, this plug will fit in a polarized outlet only one way. If the plug does not fit fully in the outlet, reverse the plug. If it still does not fit, contact a qualified electrician. Never use with an extension cord unless the plug can be fully inserted. Do not alter this safety feature.


This lamp is for indoor use only. The lamp should not be used near water. Never immerse the lamp in water or other liquids. Never cover the lamp with any object including cloth or paper as this is a fire hazard. Do not handle the bulb immediately after the light is turned off as it will be hot. This is not a toy.

### **ASSEMBLY INSTRUCTIONS:**

- 1. Install bulb. Only use bulb of specified type and maximum rated wattage or less.
- 2. Plug the electrical supply cord into the wall outlet. Use the switch located on the shade to turn the lamp ON/OFF.
- 3. Use the charging outlet located on the base of the lamp to charge phone, mp3 player or other accessory (\* It will ONLY work when lamp is plugged in).

### **CLEANING & MAINTENANCE:**

- 1. Unplug the fixture before cleaning.
- 2. Use a clean, dry, lint-free cloth.
- 3. Do not use water or other chemical cleaning agents.

#### LIMITED WARRANTY
